1. What is the major educational need this grant addresses? Please give grade level and academic area.

This equipment and curriculum teaches awareness of the effects of Fetal Alcohol Syndrome and drug use during pregnancy. All students, 8th-12th, in the FCS department will participate in the curriculum and experience of an infant affected by FAS and drug use during pregnancy. The curriculum is literacy rich and hands-on activities dealing with an infant with disabilities; disabilities that are 100% preventable!

2. Approximately how many pupils will be affected by this project, both directly and indirectly?

Enrollment is increasing in the FCS department, all students will participate. Following population trends I estimate 100 students per year will be educated with the effects of drug and alcohol use during pregnancy.

3. Describe your grant including methods, materials and objectives. Foundation grants are intended to fund a creative teaching plan, so if equipment or materials are requested it should be clearly stated as to why these are an integral part of the plan. The infant and curriculum are conducive to active and engaged learning. Holding a screaming and inconsolable infant suffering the effects of addictive behavior is powerful. I have found Reality Works infant simulators valuable tools in my

classroom. The infants are attractive, similar in size and weight to human infants, and aligned with National common core standards. Specifically, Family forms, functions, concerns, and crises; interpersonal relationships; life management skills; personal development, and marriage.

 Intrapersonal relationships, choosing to marry, parenting and child development are taught each year to students in comprehensive classes at the 8th, 9th and 10th grade levels. In depth study of Family Services (Career clusters) is offered on rotation basis. Students have the opportunity to exposure in each level, choosing an in-depth course will prepare the learner for a career in family services in the medical, caregiver or relationship field.
